The event shall be **National Historic** held under the FIA International Sporting Code including Appendices, the National Competition Rules (NCR) of Motorsport Australia, The Circuit Race Standing Regulations (CRSR), the Regularity Trial Standing Regulations, the Supersprint Standing Regulations, the Regulations for 5th Category Historic Cars, these Supplementary Regulations and any Further Supplementary Regulations, Bulletins and / or Instructions issued for the Event. This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1st, Integrity and Legal, and Risk Management Policies, which can be found in the Motorsport Australia website at www.motorsport.org.au. This Event will be conducted under and in accordance with any or all of the current Motorsport Australia COVID-19 Return to Race strategy requirements at the time of this Event.

6. ENTRIES | DETAILS

- a. Entries open on publication of these Regulations and close on **Wednesday 26th April 2023**. Entry Fees are **\$490.00**. **Current HRCC (Qld) Inc members will receive Member Discount \$50.00, per entry**. Entries received without the correct Entry Fee will NOT be included in the acceptance process.
- b. A \$30.00 discount from the entry fee is available to all those owning their own MyLaps X2 or TR2 Transponder: Refer Paragraph 19c of these Supplementary Regulations.
- c. **PLEASE NOTE:** As Motorsport Australia Motor Event Entry is used to administer this Event, Entrants are asked to lodge entries on - www.motorsport.org.au and use the **Member Portal**
- d. Each Entrant will receive 4 entry passes and 1 tender vehicle pass. **NOTE:** These passes will be available for collection from the Pit Entry Gate on arrival. Further weekend passes may be purchased with the Entry when it is lodged for a fee of \$10 each.
- e. Motorsport Australia Event Entry or paper Entry Forms must be completed in full, accompanied by the correct payment and lodged prior to the close off date. Late entries may be accepted. The maximum number of entries is 250. The Organiser reserves the right to refuse any entry, in accordance with the NCR. **PLEASE NOTE MAILING ADDRESS** is as follows; **AUTUMN HISTORIC WARWICK / PO Box 353 / Red Hill, Qld, 4059 and must be received prior to the event**.
- f. All cheques (no cash through the mail, please) are to be made payable to the **Historic Racing Car Club (Qld) Inc.** and are not considered received until honoured. A fee of \$50.00 will apply for a dishonoured cheque.
- g. **WITHDRAWALS**
 - Notification of **withdrawal** should be verbal with confirmation via the “Refund Request” function on Motorsport Australia Event Entry.
 - i. prior to 14 days before Event - Full Refund.
 - ii. 13 days to 5days (Monday 9pm) before Event- Refund Entry fee less \$30 admin fee.
 - iii. 4 days to start of Event- Entrant to send written request for consideration by Committee for Refund less 25% of the entry fee. Refer <http://www.hrcc.org.au> for HRCCQ’s full Refund Policy
 - iv. All Withdrawals must either include full bank details or cheque request before a refund will be issued.
- h. All COMPETITORS in all CLASSES **including Regularity and Supersprint** are reminded that all HISTORIC CARS must comply with the provisions of **Schedule K (Markings on Automobiles) and Articles 1.3 and 1.4 of General Requirements of the 5th Category regulations** regarding advertising and competition numbers under the General Requirements in the current Motorsport Australia Manual.
- i. Regularity and Supersprint cars **must represent the era** of competition. **PLEASE NOTE** Requirements for any replica or tribute car displaying cigarette advertising.

7. SESSIONS

- a. It is proposed that over the two days of the Event, Racing will have one Qualifying session plus four (4) Races.
- b. It is proposed that over the two days of the Event, Regularity will have one practice session plus four (4) Trials.
- c. It is proposed that over the two days of the Event, Supersprint will have one practice session plus four (4) Sprints.
- d. **The Event Program will be advised in Further Regulations.**

8. AWARDS

- a. Awards shall be in the form of Trophies and / or prizes.
- b. Individual Feature Trophy awards may be presented in the relevant heats as follows; **Bill Campbell Trophy** (1st Place Only - Group Nc), **Glenn Seton Trophy** (1st Place Only – Group A), **John French Trophy** (1st Place Only – Group C). Heats to be identified in the further supplementary regulations.
- c. Overall Group winners for all Races & Sprints shall be determined by the accumulation of points earned in all scratch races for the relevant group. Points to be Awarded as follows: First 30, Second 25, Third 22, Fourth 20, Fifth 19, Sixth 18, Etc...
- d. Awards shall be allocated on the basis of number of starters for each group in the following manner:
1st, 2nd, 3rd for Five (5) or more starters / 1st, 2nd for Four (4) starters / 1st, Three (3) or less starters.
- e. **Regularity:** results will be determined by the BEST 3 scoring trials for each competitor.

9. SCRUTINY | PRACTICE

- a. Targeted Scrutiny will be in operation at this event and vehicles that are part of this program are required to bring evidence of such to Document Check in the form of a documented log-book. Vehicles which are yet to have their initial Targeted Scrutiny audit will be required to undergo initial scrutiny.
- b. Scrutiny will take place at the circuit as follows:
 - Friday May 12 2023 between 10.30am and 4.30pm
 - Saturday May 13 2023 from 7am.
 - Sunday May 14 2023, a minimum of a safety check may take place.

Log books and Certificates of Description (where applicable) must be presented at the Scrutiny Bay with completed Self Scrutiny Forms. Each Speed and Race have their own form.

- c. **Supersprint & Regularity vehicles, not having a Motorsport Australia logbook, must undergo a safety check.**
- d. Timed Qualifying / Practice will take place on Saturday only and will be the qualifying basis for determining grid positions for the first race. Grid positions for subsequent scratch races will be determined by the finishing order of the preceding scratch race (with non-finishers and non-starters being added at the rear of the field at the discretion of the Clerk of the Course). The Organiser reserves the right to vary, combine, or add to practice and or competitive sessions, subject to the approval of the Stewards.
- e. Starting order for combined race grids will be determined by qualifying times. These will include, but not limited to, the Bill Campbell Trophy Race (all Group Nc), John French Trophy (GrpC) and Glenn Seton Trophy (GrpA).
- f. Each nominated Driver (including Regularity and Supersprint) are to complete a minimum three **(3) Timed laps** of practice. Drivers that fail to complete a practice/qualifying session may be given permission to start rear of grid in accordance with Motorsport Australia CRSR.
- g. Each nominated Driver (including Regularity and Supersprint) must practice or qualify within 130% of the pole time. Drivers that fail to do so will only start at the discretion of the Stewards in accordance with Motorsport Australia CRSR.
- h. Details of Practice times, together with Competitor Instructions and intended Event Schedule, will be contained in Further Supplementary Regulations issued for the Event.
- i. **PRIVATE PRACTICE** will be available Friday May 12 2023 8.30am to 4.30pm, \$110 for the day. **PLEASE BOOK ONLINE WITH ENTRY.**

10. SUPERSPRINT (HISTORIC SPORTS SEDANS INCLUDING GROUP U & INVITED CARS ONLY)

a. START PROCEDURE

- i. When called Cars will assemble in the Marshalling Area in order of fastest time to slowest based on their preceding session
- ii. Prior to each Sprint a 1 Minute Board will be shown
- iii. Cars will then proceed single file onto the circuit at suitable intervals as directed for a Warm-up lap. Overtaking is not permitted and the release intervals must be maintained on the Warm-up lap.
- iv. Yellow flags will be displayed at all flag posts on the Warm-up lap until the Starter displays a Green Flag for a Flying Single File Start.

b. RESULTS

- i. The winner of each Sprint will be the Driver who covers the prescribed distance (number of laps) in the quickest elapsed time. The distance will be detailed in the Event Schedule.
- ii. The overall Group winner will be determined by the accumulation of points in the first 3 Sprints. Points to be awarded as follows: First 30, Second 25, Third 22, Fourth 20, Fifth 19, Sixth 18, Etc....

11. LICENCES (INCLUDING INTERNATIONAL DRIVERS)

- a. **Racing Drivers** must hold a minimum of a current Motorsport Australia Circuit Licence with Provisional endorsement unless specified otherwise below.

- A driver must hold a minimum of a Circuit licence with an HPL Endorsement to compete in the following 5th Category vehicles:
 - i. FIA Formula One vehicle in Group O,P,Q,R;
 - ii. Indy Car vehicle in Groups O,P,Q,R;
 - iii. Group F5000;
 - iv. Formula 3000 in Group R
 - v. Formula Holden in Group R
 - vi. Sports 3000cc and over normally aspirated or over 1800cc forced induction in Group M, O, P, Q & R;
 - vii. FIA Group C1 & C2 Prototype; and

- viii. An Automobile deemed to be of a performance level requiring an HPL as determined by the Historic Motorsport Committee

NOTE: A driver holding an International licence must also have an HPL Endorsement to compete in any of the above vehicles in a Motorsport Australia circuit race competition up to National Championship

- A full Circuit licence will be the minimum requirement for the following 5th Category Historic vehicle Groups:
 - i. Any vehicle requiring an HPL;
 - ii. FIA Formula 2 in Groups Q & R; and
 - iii. Sports over 2000cc in Group Q & R

- b. Regularity & Supersprint** Drivers must hold a minimum of a current Motorsport Australia Speed Competition Licence.
- c. All** Drivers must have proof of current membership of a Motorsport Australia affiliated Club.
- d. No licences will be available for issue at the Circuit.**
- e.** All Licences, Motorsport Australia pass books, competition records and Club membership cards must be available for inspection at any time during the course of the Event. Licence Checks will be completed prior to the event.
- f.** Motorsport Australia Vehicle log books, Historic Technical Passport's (HTC), and Certificate of Description's (COD) must be presented at **Scrutiny** and be available, if required, for inspection at any other time during the course of the Event. Scrutineering will take place in the Scrutineering Bay at the rear of the carports.

Each Competitor and Driver must hold a Motorsport Australia Competition Licence as listed above unless they comply with (a) or (b) below.

(a) hold a Motorsport New Zealand competition licence and Tasman Visa valid for the Event; or

(b) hold a minimum of the highest grade National Licence issued by a foreign ASN together with an authorisation issued by that ASN for the Event; each such Driver and Competitor:

(i) shall be ineligible to score points in any Championship/Cup/Series/Trophy/etc connected with the Event; and

(ii) must receive an authorisation to compete from Motorsport Australia prior to the Event;

The Organiser confirms that the Circuit to be used for this Event holds the necessary Motorsport Australia National Track licence for each of the competitions nominated in these Supplementary Regulations.

12. COMPULSORY DRIVERS BRIEFING

Details to be advised in the Further Supplementary Regulations.

13. CHANGE OF DRIVER

A change of Driver may be permitted subject to the NCR. **See the Secretary of the Event if a Driver change is required.**

14. NOISE EMISSION

All competing vehicles must be fitted with an effective muffler and are **not to exceed** a noise level of **95dB (a)** on the standard 30 metre run-by test.

15. CHANGE OF PROGRAMME

The Organiser reserves the right to vary the Event schedule under the CRSR, in the Motorsport Australia Manual, and under the NCR.

16. JUDGES OF FACT

- a. The Judges of Fact in respect of the start / finish and noise emission shall be the Clerk of the Course, Deputy and Assistant Clerks of the Course, Secretary of the Event, Chief Timekeeper, Chief Scrutineer, Starter and Assistant Starters as listed in the Supplementary Regulations, Further Supplementary Regulations or Bulletins for this event.
- b. Judge of Fact for speed in the Pit Lane and driving over kerbs will be notified by Bulletin.

17. FIRE EXTINGUISHERS

- a. Competitors will be required to pay for the servicing of any fire extinguishers used on their vehicle.
- b. Each Race Competitor must provide at least 1 operable 4.5kg ABE Powder fire extinguisher for their paddock or pit area. Ref: Circuit Race Standing Regulations 8.8

18. ABANDONMENT, POSTPONEMENT & CANCELLATION

The Organiser reserves the right to be abandon, postpone or stop the Event in accordance with the NCR.

19. TIMING

- a. The My Laps electronic timing system will be in use at this event. Each vehicle must be fitted with a functioning compatible transponder for all on track activities. Failing to do so may result in no times being recorded and the driver requiring steward's permission to start rear of grid for their subsequent race.
- b. **All Competitors, not owning their own MyLaps X2 or TR2 transponder** can hire a timing transponder, price included in the entry fee. A \$100 deposit will be required for the transponder; this will be refunded upon return of the transponder at the end of the Event.
- c. **A discount of \$30.00** is available for all who own their own MyLaps X2 or TR2 Transponder. **Available in the "Extras" section of Motorsport Australia Event Entry.**
- d. Times are available from each Group Leader and will also be uploaded to My Laps website after each Round.
- e. Timing transponders, for those requiring them. Time for collection will be published in the further supplementary regulations for this event Timers will be available from outside the windows **ground floor of the Timing Tower.**
- f. Any Competitor damaging or not returning a transponder will be liable for the replacement cost of up to \$500.00. Any bracket broken or not returned will incur a fee of \$15.00.

20. FUEL

Fuel must comply with Technical Appendix, Schedule G of the Motorsport Australia Manual.

Fuel will not be available at the Circuit.

21. CTP. INSURANCE EXTENSION

PLEASE NOTE: Vehicles road registered in Queensland under the "Transport Operations (Road Use Management / Vehicle Registration) Regulation 1999" require a Compulsory Third-Party Insurance (CTPI) extension valid for this Event.

22. INSURANCE

- a. Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the event. Further details can be found in the Motorsport Australia Insurance Handbook, available at www.motorsport.org.au.

23. PROTESTS

Any protests must be lodged in accordance with the Motorsport Australia NCR.

24. GENERAL

a. Integrity, Alcohol, Drugs and Other Substances

Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy, Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at www.motorsport.org.au.

Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.

Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

- b. **Pit Lane speed limit shall be 40 kph.**
- c. Due to pedestrians of all ages and capabilities, **paddock speed limit for ALL vehicles shall be 10kph (fast walking pace).**

25. PIT | PADDOCK

- a. The Pit/ Paddock Area at Morgan Park is limited. With control and your co-operation we can accommodate Race Cars and Tender Vehicles. A limited area is available for transporters, motor homes and camping within the confines of the Paddock Area. **Only one tender vehicle (with tender vehicle pass clearly displayed) per Entrant will be allowed into the Paddock Area during the event.**
- b. PIT / PADDOCK Marshals will be available to assist with all below.
- c. ALL TRAILERS should be parked in the "Trailer Park" on the left hand side of the entry road to the Paddock Area, there will also be limited trailer parking (as sign posted) at the far northern end of the Paddock Area.
- d. **ENTRY to Paddock Area for competitors is AFTER 1.30pm Thursday May 11, 2023.** The Entry Gate will be manned Thursday 1.30pm to 6.00pm, Friday & Saturday from 6.30am and Sunday 6.30am till finish of the Event.
- e. **Paddock Area** will be laid out with WORKING BAYS 5.0 wide x 12.0m deep, **if you need more space see contact below.**
- f. **POWER SITES** are available at no extra charge. See the Paddock Manager for access. The sites are all located near the 8 Power Poles behind (Eastern Side of) the Lower Level Carports. If you require power, please put your requirements in the "Comments Section" when you do your entry or contact HRCC on 0424 321 072. OH&S restricts the use of unprotected power leads on the ground and NO double adaptors may be used.
- g. **CAMPING** is allowed for competitors along the East side fence and North end of the Main Pit Area. NOTE: there is no power close to these areas.
- h. PANTEC'S / RIGS over 9.0m long please advise, see item J. below, of your attendance, at least 2 weeks in advance, advise number of Race Cars, Competitors name and area [size L X W] required include side opening doors and awnings. NO RESERVATIONS. We will ONLY make allowance for the number of Pantecs / Oversize we are advised of. Please See Contact below
- i. **CARPOR** hire costs \$120.00, these must be BOOKED and PAID with your entry as there is a limited number available. Carports will be allocated at the discretion of the Promoter. Only fully paid entries will be considered for allocations. Carports are 3.6 x 6.0m with power every 4th bay. The tender vehicle parking will be as directed.
